DECLARATION OF HEALTH AND OPERATIONAL COMPLIANCE AGREEMENT

Armour Heights Community Centre Children's and Tiny Tots Committee (AHCC) and the Armour Heights Community Centre (the facility) appreciates and expects your partnership and cooperation in complying with the opening guidelines and social distancing protocols established by the Ontario Government. AHCC is requesting that you observe our rules for operating under COVID-19 restrictions. AHCC is permitting those registered to access the facilities and participate in activities based on the assurances made in this Declaration and Agreement. Accordingly, any false statements made in this Declaration and Agreement or any failure to comply with the requirements detailed below may lead to removal of the participant from the program without a refund.

As you are aware, COVID-19 can be transmitted by asymptomatic persons. Consequently, the statements made by participants contained in this Declaration cannot provide certainty that the virus will not be transmitted. AHCC is taking prudent steps to impose and enforce appropriate protocols to keep participants safe, but there can be no assurance that the virus will not be contracted by participants during our programs. This is a risk that each participant/parent/caregiver must assess themselves, and if they choose to attend AHCC programs and participate in its activities, each participant will be voluntarily assuming the risk of either contracting the virus or transmitting it to others.

AHCC's COVID-19 Protocols & Procedures will be updated from time to time.

1. I hereby declare that I have read, understand, and agree to abide by AHCC's COVID-19 Protocols & Procedures for each of the activities in which I participate, and for use of AHCC's facilities, posted on AHCC's website and updated from time to time as communicated by AHCC, The City of Toronto and the Province of Ontario. I waive any rights to participate in any classes or use AHCC's facilities, if I fail to comply with these policies.
2. I hereby declare that neither I nor anyone in my household has experienced any of the COVID-19 symptoms identified by Public Health Ontario, in the last 14 days, including without limitation:
 - Fever
 - Cough that is new or worsening
 - Shortness of breath, unable to breathe deeply
 - Extreme tiredness that is unusual, lack of energy
 - Headache that is unusual or long lasting
 - Runny, stuffy, or congested nose not related to seasonal allergies
 - Sore throat or difficulty swallowing
 - New loss of sense of taste or smell
 - Falling down often
 - Muscle aches or chills
 - Pink eye (conjunctivitis)
 - Digestive issues such as nausea, vomiting, diarrhea, or stomach pain

I agree that if I or anyone in my household experiences any of these symptoms after submitting this Declaration, I will then not visit Armour Heights Community Centre, nor will I permit any of my children who are registered to visit the facility, for a minimum period of 14 days after these symptoms have completely gone away.

3. I hereby declare that neither I nor anyone in my household has returned from travelling anywhere outside of Canada in the last 14 days. If I or anyone in my household travels to anywhere outside of Canada after submitting this form, I will then not visit Armour Heights Community Centre, nor will I permit any of my

children who are registered to visit the facility, for a minimum period of 14 days after the date of return to Canada.

4. I agree that on every occasion that my child attends a class at AHCC after the date of this Declaration and Agreement, attendance will be recorded. I agree that this recording of attendance will constitute my confirmation that at the time of each attendance at the facility all of the statements in this Declaration and Agreement continue to be true.
5. I acknowledge that COVID-19 can be transmitted by asymptomatic people, and that there can be no assurance given by AHCC that I, and any of my children who are attending programs, will not contract COVID-19 while visiting or using the facility and participating in its activities. Accordingly, I agree that in electing to access the facilities and participate in AHCC activities, and in allowing any of my children who are registered to do so, I am voluntarily assuming the risk that I and my children may contract COVID-19 while at the facility.
6. I hereby, personally, and on behalf of any of my children who are registered, expressly waive and release any and all claims against AHCC and The City of Toronto together with its officers, directors, administrators, servants, agents, representatives, volunteers and their successors and assigns (collectively the "Releasees") which I and my children have or may in future have for damages arising out of contracting COVID-19. I, personally, and on my children's behalf, agree not to make or bring any such claim against AHCC or The City of Toronto or any other Releasee, and forever release and discharge AHCC and The City of Toronto and all other Releasees from liability under such claim.
7. The terms that I have agreed to in this Declaration and Agreement will remain in effect until AHCC and The City of Toronto declare that the requirements in this Declaration are no longer in effect.
